Question	Why did Parliament eventually repeal the Stamp Act, which taxed goods such as newspapers and playing cards?	The Stamp Act was a law passed by the British Parliament that taxed goods that made day to day life challenging for the colonists.
		The question asks why the British Parliament changed its mind and repealed the Stamp Act after it had been in effect for a period of time.
Α	The colonists established a blockade against British goods.	Incorrect – The colonists still allowed British goods to come to the colonies so they did not create a blockade (where nothing would be permitted to come into the colonies by ship).
