## THE INFLUENCE OF THE U.S. CONSTITUTION

- 1. As a reminder, constitutional government is based on a written set of laws that all citizens agree to, and that written set of laws is called a constitution. The US Constitution includes the principle of limited government. Limited government is the idea that the government can do only what the people allow it to do. Checks and balances, separation of powers, individual rights, rule of law and due process of law are all ways in which the power of government is limited.

- 3. Remember, a constitution is a written set of laws that all citizens agree to, and a constitutional government is based on that set of laws. The Founding Fathers set a precedent around the globe by drafting the U.S. Constitution. It was a landmark event in the history of governments, and reinforced the idea that governments should be ruled through the consent of the governed instead of monarchs or elites. The will of the people would be stronger than a tyrannical government.
- 4. This concept of a republican government inspired European colonies such as Mexico and the Philippines, and dynasties in China to reform the oppressive governments they lived under. They cited works such as Rights of Man by Thomas Paine, separation of powers, and the idea of developing their own freely elected governments with more limited power.
- 5. The United States was the first nation to create a federal level of government with an elected head of state called "President" that is constitutionally created. Modern countries such as France, Liberia, Australia, Canada, Germany, and Switzerland have referenced the U.S. Constitution when creating their governments.
- 6. One important feature that is evident in most constitutions, is the creation of a Bill of Rights, or a list of personal freedoms for the people that are protected by that constitution. The Founding Fathers knew that there could not be a supreme and fundamental law without a separate document listing individual rights. The authority of a government cannot be based on good intentions alone, as mentioned by James Madison (1788) in essay No.51 of the Federalist Papers.
- 7. "If Men were angels, no government would be necessary. If angels were to govern men, neither external nor internal controls on government would be necessary. In framing a government which is to be administered by men over men, the great difficulty lies in this: you must first enable the government to control the governed; and the next place, oblige it

to control itself."

- 8. Perhaps the most important place we see the influence of the US Constitution on other governments, though, is our own country, and that is at the level of the individual states!
- 9. Each state in the Union is guaranteed, by our Constitution in Article IV, Section 4, a republican form of government. Each state in the United States has a state constitution and structure very similar to that of our federal or national government. This includes limits on government powers through three branches of government with separation of powers and checks and balances. The state constitutions provisions for due process and the rule of law and also contain a bill of rights of some kind to protect individual rights.
